

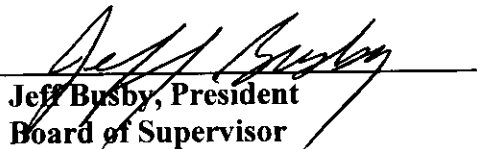
**ORDER: SPREAD ON THE MINUTES THE PAYMENT OF \$3,647.00

COURT COSTS**

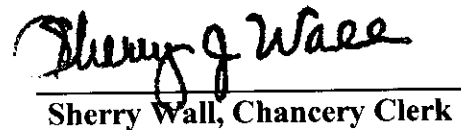
