


**ORDER: SPREAD ON THE MINUTES THE PETITION TO INCREASE
ASSESSMENTS FOR 2013 REAL PROPERTY**


Motion was made by Chad McLarty, duly seconded by Mike Pickens, to spread on the minutes the Petition to Increase Assessments for 2013 Real Property.
