


**ORDER: SPREAD ON THE MINUTES THE COURT ORDER


The vote on the motion was as follows:

OF LAFAYETTE COUNTY, MISSISSIPPI

ORDER APPOINTING DEPUTY OF YOUTH COURT

WHEREAS, it appears that the volume of business before the Youth Court Division of the Chancery Court of Lafayette County, Mississippi, is such that it requires a person to expend a great amount of time in the preparation of the Youth Court Docket, Minute Book, the filing of papers and pleadings, the issuance of summonses and other processes, and other ministerial functions, all of which are necessary to the efficient and proper operation of that Court; and

WHEREAS, to that end it is proper that one Deputy Chancery Court Clerk be selected to also serve as Deputy Clerk of the Youth Court of Lafayette County, Mississippi, whose duties will involve handling the administration of the Youth Court in addition to those general duties as a Deputy Chancery Court Clerk; and

WHEREAS, Sherry J. Wall, the duly elected, acting and qualified Chancery Court Clerk of Lafayette County, Mississippi, has selected Kerri L. Coleman, one of her Deputy Chancery Clerks, to serve as Deputy Clerk of the Youth Court of Lafayette County, Mississippi; and


WHEREAS, as is authorized by Section 19-9-96, Mississippi Code of 1972, "clerical or other court appointed personnel are authorized to be paid from the Youth Court fund of a County"; and

WHEREAS, the Board of Supervisors of Lafayette County, Mississippi, at the request and suggestion of this Court, have chosen to fund the operation of the Lafayette County Youth Court by the imposition of a special tax for that purpose and there are and will continue to be sufficient funds to finance a part of the salary of a Deputy Clerk of Youth Court; and

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED, that Kerri L. Coleman, Deputy Chancery Clerk of Lafayette County, Mississippi, be and she is hereby appointed as Deputy Clerk of the Youth Court of Lafayette County, Mississippi; and she shall be paid the sum of One Thousand Dollars (\$1,000.00) per month from the Youth Court fund; and she shall serve as such at the pleasure of Sherry J. Wall, Chancery Court Clerk, and this Court.
