Justice Court Collections Fund

Mass. Code Ann. Section 9-11-35 authorizes the creation of the Justice Count Collections Fund administered by the MS Department of Revenue (DOR). There is created a \$7.50 assessment under the provisions of Section 99-19-73 (Other thisdemeanars) that will be deposited into the Justice Count Collection Fund can be distributed to participating counties. At fines and assessments must be collected by the count system and remitted to DFA in the usual monthly settlements.

In order to quality as a participating municipality and receive any distribution of this Fund, the governing authority of the county must contract with a private attorney or private collection agent or agency to collect delinquent fines and other assessments as provided in Miss Code Ann. Section 19-3-41 (2). Using a county employee does not dualify the county to receive the distribution. The county must contract with a collection entity.

That county must submit to the Separtment of Revenue the following information to be considered as participating:

- 1. The name of the county,
- 2. The name and address of the person or area that will be the contact for this program;
- 3. The name of the collection entity; and
- 4. A copy of the contract with the collection entity. The contract should include:
 - a. The services being performed by the collection entity (collection of delinquent assessments & fines)
 - b. The date the contract was signed

Only those countries which have contracted with a collection entity in accordance with the statute and have submitted the above information will be considered participating and are eligible for a distribution of the amount of the Justice Court Collections Fund fees. The county becomes eligible at the time the contract is in effect. Distributions will begin the next quarter and will not be retroactive prior to the time of contract.

Department of Finance and Administration (DFA) will deposit the money into the funds using a formula approved by the State Auditor's Office. Each month two reports are issued showing the mones being deposited, the Report of City/County Fees Summary and the Report of City/County Fees. The DOR will consider those reports as the source documents on which to base the amount of distribution to the carticloating counties.

By the 10° of the month following the end of each calendar quarier (April 10° for Jan – Mar, July 10° for Apr – Jun, October 10° for Jul – Sep, and January 10° for Oct – Dec), the DOR will send a request of a distribution amount to be issued to each participating county to DFA. The participating county is not required to such its distribution.

The monies from this Fund are to be used for

- Support of salaries of justice court personnel,
- Purchase, operation and maintenance of software and equipment.
- · Facility planning and improvement and
- Other expenses incurred for the purpose of collecting fines and assessments within the justice court system.
