


**ORDER: SPREAD ON THE MINUTES THE CONTINUATION BOND


The vote on the motion was as follows:



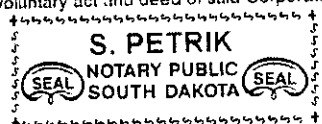
