



ARTICLES OF AGREEMENT

This agreement made this 3rd day of August 2015, by and between Lafayette County Board of Supervisors, hereinafter referred to as COUNTY, and Tri-State Consulting Services, Inc., hereinafter referred to as CONTRACTOR,

WITNESSETH:

WHEREAS, the COUNTY is desirous of employing CONTRACTOR for providing certain mapping services and that CONTRACTOR is desirous of performing such services:

NOW THEREFORE, and in consideration of the mutual terms, conditions, and promises herein contained, CONTRACTOR does hereby agree to furnish said mapping services in Lafayette County.

TECHNICAL SPECIFICATIONS

All work will be governed by the request for proposal specifications for map maintenance and the bid response by the CONTRACTOR dated the 30th day of June 2015.

STARTING AND COMPLETION DATES

Work on the project shall commence no later than the August 2015 and shall be completed no later than the thirty-first day of March 2016.

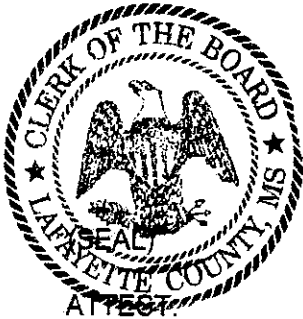
PAYMENT AND TERMS

In consideration of the CONTRACTOR furnishing the COUNTY the services contracted for herein and such services being acceptable to the COUNTY, the CONTRACTOR shall receive the sum of FORTY FIVE THOUSAND FIVE HUNDRED DOLLARS (\$45,500). COUNTY shall pay CONSULTANT according to the following schedule:
