

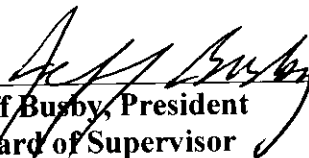
**ORDER: APPROVING CLAIMS DOCKET AS PRESENTED
