

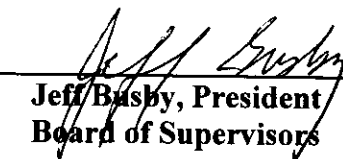
**ORDER: SPREAD ON THE MINUTES THE 2014 PERSONAL PROPERTY
