

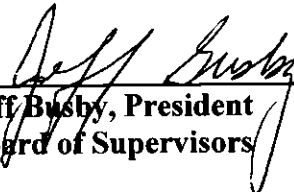
**ORDER: SPREAD ON THE MINUTES THE 2015 REAL PROPERTY
