

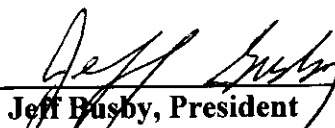
**ORDER: SPREAD ON THE MINUTES THE 2015 REAL PROPERTY

Motion was made by Chad McLarty, duly seconded by Mike Pickens, to spread on the minutes the 2015 Real Property Petition to Increase Assessment.

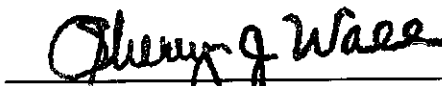
The vote on the motion was as follows:
