

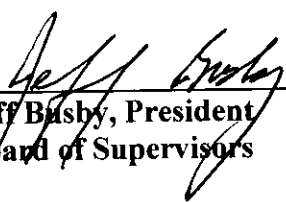
**ORDER: SPREAD ON THE MINUTES THE SOLID WASTE ACCOUNT
