


**ORDER: SPREAD ON THE MINUTES THE OFFICIAL BOND AND OATH OF

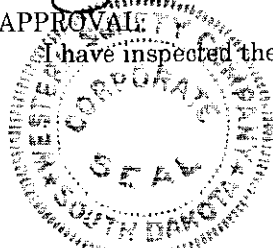

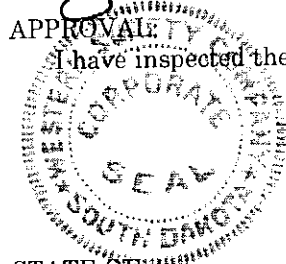

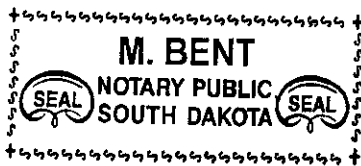
