


**ORDER: TABLE DEVELOPER'S REQUEST TO REDUCE

This letter is being written to confirm the construction of the roadway in the above referenced development has been completed in accordance with the original construction documents except the final lift of asphalt.

Our client is requesting that the performance bond currently in place be reduced to cover the final lift of asphalt plus 15% as required by the Lafayette County Subdivision Regulations.

I have also attached a copy of the Registration Form for Residential Lot Coverage which has been executed by the buyers of lots 3, 4 and 5 and effectively transfers responsibility for erosion control to the lot owner.

We would like to have the request to reduce the bond heard at the March 7, 2016 Board of Supervisors meeting. Please let me know if there is anything else required by your office for us to be on this meeting agenda.
