

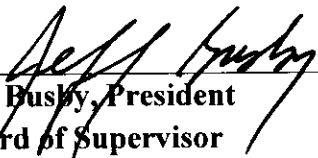
**ORDER: SPREAD ON THE MINUTES SOLID WASTE WRITE-OFFS FOR MARCH
