

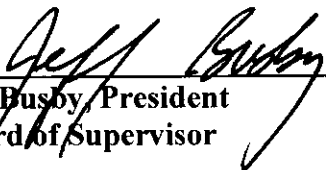
ORDER: APPROVE SOLID WASTE WRITE-OFFS FOR MAY 2016

Motion was made by Mike Roberts, duly seconded by Chad McLarty, to approve Solid Waste write-offs for May 2016.

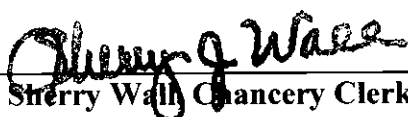
The vote on the motion was as follows:
