

Chad McLarty recused himself from the meeting at this point.

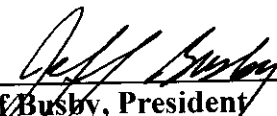
**ORDER: ACCEPT PLANNING COMMISSION'S
