

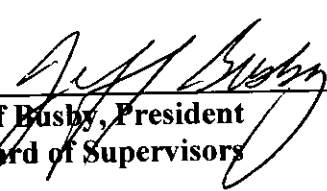
ORDER: APPROVE SOLID WASTE WRITE-OFFS FOR JULY 2016

Motion was made by Mike Roberts, duly seconded by David Rikard, to approve the Solid Waste write-offs for July 2016.

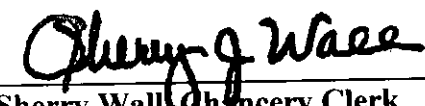
The vote on the motion was as follows:
