
Motion was made by Kevin Frye, duly seconded by David Rikard,

Montgomery Technology Systems, LLC is pleased to provide a quote for all necessary material and labor to install a complete, fully functional and operational locking and intercom control system for the above referenced project. MTS is proposing to provide a Montgomery Technology, Inc. (MTI) control system. This quote is based on original project documents and out site visit.

Scope of Work

MTS will replace the following existing MTI control panels with new All-in-One stations:

1. CP-HJ
2. CP-KL
3. CP-MN
4. CP-PQ

Each of the above stations will consist of an Elo 22C3 22" All-in-One control station running MTI ProVision, a microphone for intercommunications and a BRG1350 UPS.

MTS will replace TS-1 with a new touchscreen control station. The control station will consist of a HP 800 series computer running MTI ProVision, two (2) 22" Elo touch screen monitors with built-in speakers, a microphone for intercommunications, and a BRG1350 UPS. MTS will also provide a new logging computer and 22" LCD monitor to replace the existing logging computer.

MTS will replace the existing PLCs with new MTI Embedded Controllers. MTS will provide new MTI digital intercom amplifiers to replace the existing amplifiers.

MTS will provide a new UPS for all head end equipment. An On-line UPS system will be utilized. The UPS system will be sized to provide fifteen (15) minutes of run time for all systems included in this quote. MTS will provide a new HP 2620-24 24 port network switch in the local equipment room.

MTS will reuse all existing field devices, cabling and cabinets as is except where otherwise noted. MTS will assist in troubleshooting problems with existing field devices. Once an existing field device is found to be defective, it will be the facility's responsibility to repair or replace the existing device.
