


**ORDER: AUTHORIZE PETITION REDUCTIONS AND INCREASES IN

Motion was made by Chad McLarty, duly seconded by Mike Roberts, to accept the Petition Reductions and Increases in property tax assessment.


The vote on the motion was as follows:
