


**ORDER: AUTHORIZE THE JUSTICE COURT CLERK TO ATTEND THE

Reservations for this event may be made by calling the Gold Strike reservations at 1-888-245-7829 and informing the reservationist that you are attending the Justice Court Clerks Conference sponsored by the Mississippi Judicial College (Group Code: 1705JUSTIC). *Although your room will be placed on the master bill of the Mississippi Judicial College, you must provide a credit card for the room to be held. If it becomes necessary to cancel your reservation, then you will need to contact the Gold Strike Casino within 72 hours of the scheduled check-in time.*

Gold Strike Casino has reserved a block of rooms for you for the night of Thursday, May 11, 2017. The Mississippi Judicial College will pay the conference rate of \$68.00 (which includes a \$9.00 resort fee) for one room on the night of May 11, 2017, for clerks living more than 30 miles from Robinsonville.
