

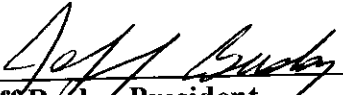
**ORDER: AUTHORIZE SOLID WASTE WRITE OFFS FOR MARCH

to authorize Solid Waste Write Offs for March 2017.

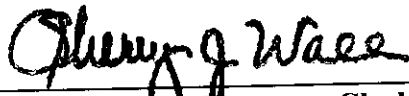
