

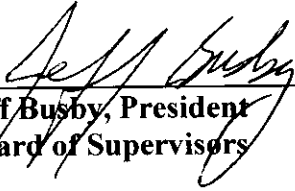
**ORDER: AUTHORIZE WRITE-OFFS FOR JUNE 2017 SOLID WASTE
