


**ORDER: APPROVE TRAVEL FOR JUSTICE COURT CLERK, JILL CARWYLE,

Please bring a copy of your county's tax exempt certificate and it must be presented at the time of check in. The tax exempt is only good for sales tax not tourist tax. If you are paying with a county's check or by check, please make sure that your check reaches Hollywood Casino fourteen (14) days prior to arriving. Room block will be held until August 06, 2017. Be sure and mention you are with the Justice Court Clerks Association to receive the \$69.00 room rate.
