

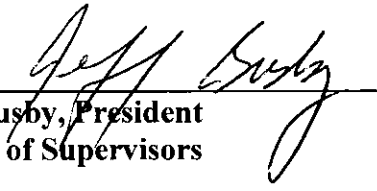
**ORDER: ACCEPT INCREASES AND DECREASES IN REAL AND
