

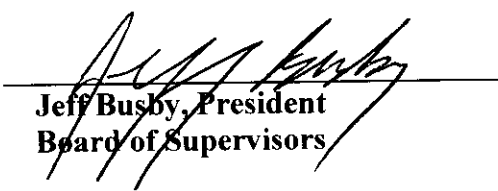
ORDER: APPROVE SOLID WASTE WRITE OFFS FOR NOVEMBER 2017

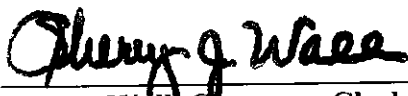
Motion was made by Mike Roberts, duly seconded by David Rikard, to approve Solid Waste write offs for November 2017.
