Further, any maintenance, repair, or construction shall be done in such a manner as to occasion the least possib interference with the normal flow and safety of traffic. |

The Applicant further understands that the Utility's engineering, plant, or other personnel will be responsible for the staking and construction supervision of the work set out above and as shown on the attached plans.

- To cooperate with the Utility Company in every way to avoid conflicts in the locations, construction, and maintenance of the County Highway and Utility Facility.
- (2) To use any and all legal means to see the Policy Standards, except to the extent of any variance shown on the plans filed herewith and approved are complied within the facility installation.
- (3) If the County Engineer or other authorized representative of the Board of Supervisors approves the drawings, sketches, and plans submitted by the Applicant, he shall so indicate by signing and dating the Permit Approval at the end of this Application, and the Applicant may proceed with the installation; if the drawings, sketches, and plans are not approved, he shall promptly notify the Applicant, and advise it of the reason or reasons. He will also act as the duly appointed representative of the Board of Supervisors and will give his approval to the completed work as being in compliance with the location and standards shown in the Policy and in this Agreement for the installation.
- (4) Should any term or provision of this Applicant Agreement conflict with the law of the State of Mississippi, the Mississippi Constitution, or the Untied States Constitution, or impair or deny to the Applicant or the County any right protected thereby, it shall be deemed amended to conform to said law of Constitution.

- 3. Road crossing shall be bored under paved road in appropriate casing.
- 4. All other facilities not located with the County right-of-way shall be located in easements obtained from the appropriate land owner.
