

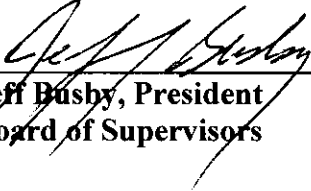
ORDER: AUTHORIZE BUDGET AMENDMENTS
