

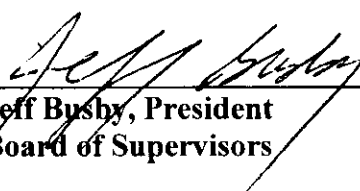
**ORDER: SPREAD ON THE MINUTES SOLID WASTE WRITE OFFS FOR

Motion was made by Mike Roberts, duly seconded by Kevin Frye, to spread on the minutes Solid Waste write offs for February 2018.

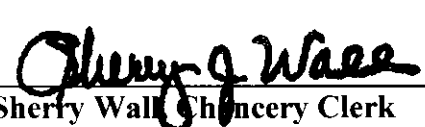
The vote on the motion was as follows:
