



2.4.3 North Mississippi Recycling Solutions

The privately owned North Mississippi Recycling Solutions began operations in 2015. The facility located on County Road 3067 in Lafayette County provides approximately 22.5 acres of disposal area within a 39.8 acre property located south of Oxford near the existing City of Oxford transfer station. The facility consists of a Class I rubbish landfill and processing facility for recycling. Class I rubbish material is accepted for disposal and waste material, mainly construction debris, is processed and separated for recycling. These recyclable goods primarily consist of concrete for crushing and wood product for chipping. Cardboard and acceptable plastics are transferred to the City of Oxford recycling center. The operation of the North Mississippi Recycling Solutions facility meets a need not previously available to Lafayette County as the existing Oxford rubbish landfill does not allow disposal of construction debris.



Reported tonnage accepted has increased from 12,241 tons in 2015 to 36,521 tons in 2017, an annual average of 23,646 tons. Recycled tonnage has increased from 30 tons in 2015 to 55 tons in 2017. The Service Area has increased from Lafayette County to now include Calhoun, Lee, Marshall, Panola, Pontotoc, Tate, Union, and Yalobusha Counties.

The facility operation complies with local land use and zoning requirements and results in no change in the current outcome of waste disposal in the County. The proposed service area is consistent with the Three Rivers Solid Waste Management Plan.
