IN JACKSON, MISSISSIPPI**



Supervisor Mike Roberts, voted yes

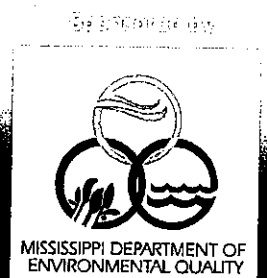
After the vote, President Busby, declared the motion carried, this the 16<sup>nd</sup> day of July, 2018.

# Mississippi Class I Rubbish Site Operator Certification Training

Operator Training Course – August 14<sup>th</sup> & 15<sup>th</sup>, 2018  
Cabot Lodge – Millsaps, Jackson, MS



## Fulfill the State of Mississippi's Certification Requirements for Class I Rubbish Site Operators

This course offers interested persons an opportunity to fulfill state requirements for the Class I Rubbish Site Operator Certification and to update their knowledge of Class I Rubbish Site regulatory and operational requirements. The Mississippi Department of Environmental Quality (MDEQ) will also allow currently certified operators to attend the course as a refresher course for Continuing Education Units (CEUs). The course involves a day and a half class with a written examination on the second day. Persons who attend the course, pass the written examination, and meet the eligibility requirements may apply to MDEQ for a certificate of competency. The exam will not be required for those persons attending for CEU's only. Attendees will receive 10 hours of CEU's for attending the full class to be applied towards renewal of their certification.

**Advance registration is required.** There will be no registration cost for the training; however, all lodging, meal, and transportation costs are the responsibility of the attendees.

## Registration and Course Schedule

The upcoming rubbish site operator training course will be held on **Tuesday, August 14<sup>th</sup>** and **Wednesday, August 15<sup>th</sup>, 2018** at the Cabot Lodge-Millsaps at 2375 North State Street in Jackson, MS.

A map and directions will be provided to registrants with a registration confirmation letter. Course check-in will begin at 7:30 a.m. on both days of the course. Sessions both days will begin at 8:00 a.m. and will adjourn at 4:30 p.m. on **Tuesday**. On **Wednesday**, the course will end around noon, upon completion of the examination. Persons who are currently certified and are only attending for CEU's may leave upon completion of the sessions and prior to the examination. The daily schedules will include morning and afternoon refreshment breaks. Lunch is on your own at noon.

Course instructors will include the staff of MDEQ and FTN Associates, Ltd. of Little Rock, Arkansas.

Training course materials, notebook, and break refreshments will be provided. It is recommended that attendees bring writing pens and/or pencils and a calculator.
