

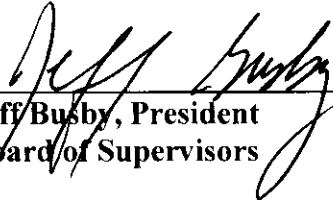
**ORDER: SPREAD ON THE MINUTES SOLID WASTE WRITE-OFFS FOR

Motion was made by Mike Roberts, duly seconded by Chad McLarty, to spread on the minutes Solid Waste write-offs for August 2018.

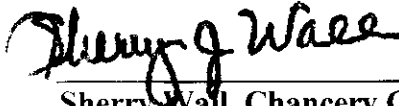
The vote on the motion was as follows:
