


**ORDER: APPROVE COMMERCIAL SUBDIVISION PLAT AMENDMENT FOR  
FIELDSTONE FARMS (PHASE II)**


Motion was made by David Rikard, duly seconded by Kevin Frye, to approve commercial subdivision plat amendment for Fieldstone Farms (Phase II).

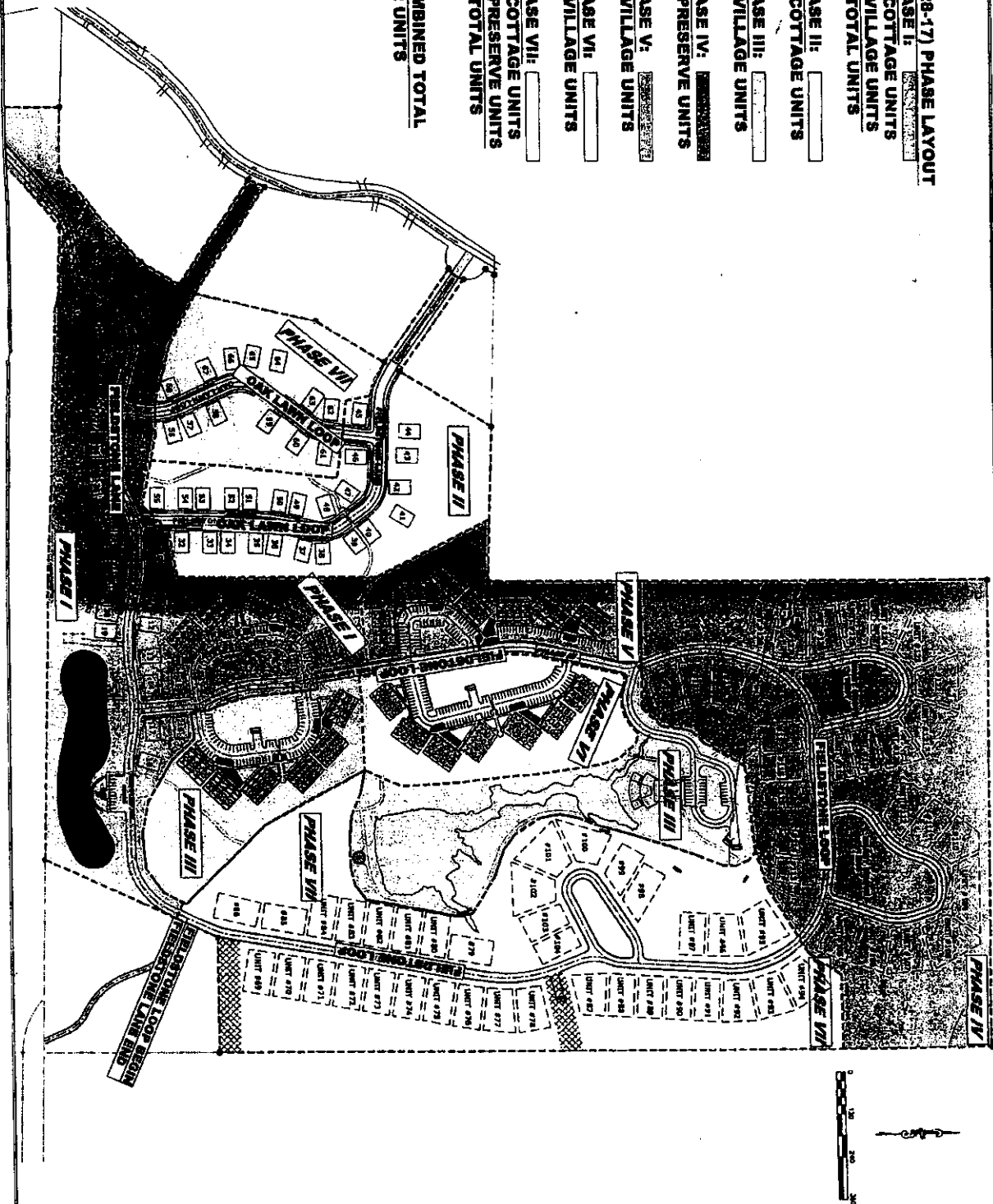
