


**ORDER: SPREAD ON THE MINUTES RECEIPT OF CERTIFICATE FROM

The vote on the motion was as follows:

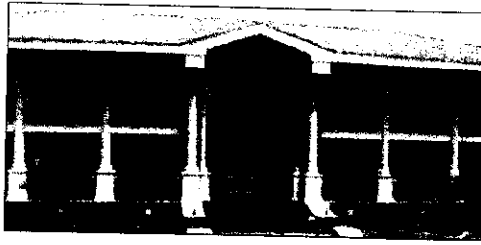




