


**ORDER: ACCEPT AGREEMENT WITH DON SMITH FOR ELECTIONS

Hello,

I'm sending you this letter that contains the revised fees that I'm willing to accept to remain being your Election Technician during every Election in your county until farther notice. With a 5 days minimum the fees are as follows:

1. Maintaining and Servicing the TSX's, Electronic Pollbooks, and OS Units before each Election.
2. Pre-Election Preparation (Which includes clearing and programming Memory Cards, Encoders, and Voter Access Cards.
3. The fee for these services will be \$400 per Day (up to 8 hours)
4. On Election Day \$600 (unlimited hours). For Post-Election days the fee is \$400 per Day.
5. Lafayette County/Election Commissioners will be responsible for my Hotel reservations when a hotel room is needed.
6. Plus \$.50/mile for mileage. All training courses that's needed by the Tech will be paid my the County. Also, the Tech will be paid \$175 + mileage for training.

I hope that you find these fees reasonable for the service that I guarantee you. Some of these rates are negotiable, if needed.

With a 5 days minimum the fees are as follows:

Building the Database for each Election. (After an all-expense paid training paid by the county)

Maintaining and Servicing the TSX's and OS Units before each Election.

Pre-Election Preparation (Which includes clearing and programming Memory Cards, Encoders, and Voter Access Cards.

The fee for these services will be \$350 per Day (up to 8 hours)

On Election Day \$450 (unlimited hours) For Post-Election days the fee is \$350 per Day.

I feel that these fees are reasonable for the service that I guarantee you. But if you feel that these rates are too much for your budget, I'm willing to negotiate.
