

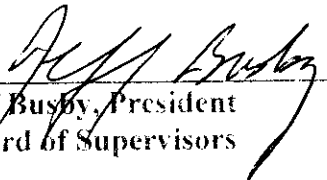
**ORDER: APPROVE NEW VALUATION OF PROPERTY PER MASIT APPRAISALS.**
