

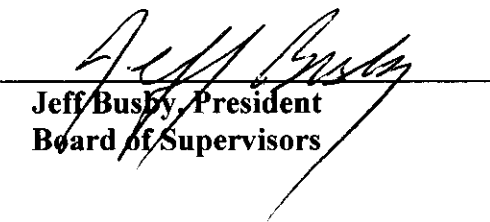
**ORDER: AUTHORIZE REDUCTION AND INCREASES IN ASSESSMENTS

Motion was made by Chad McLarty, duly seconded by David Rikard, to authorize reduction and increases in assessments for personal and real property.

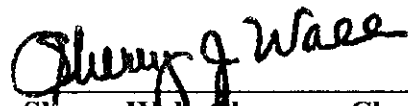
The vote on the motion was as follows:
