Brian Crockette - move salary from \$47,800 to \$50,600

DeAndre Patrick - move salary to \$38,600 - achieved Skilled Driver status

Keuntae Booker – move salary to \$38,600 – achieved Skilled Driver status (quick note on this kid: very impressive young man and has worked hard to achieve this position. He comes in on his day off and runs/practices with each type of truck...and hasn't been paid for it...all on his own)

Randy Kessler – move salary from \$38,800 to \$44,600 – Litter Foreman

Kenneth Drewery – move salary from \$34,800 to \$36,000 – Assistant Litter Foreman

Request for Full Time Employees:

Jonathan Brownlee – starting salary of \$30,600 – he will be used to replace Allen Driver who will be promoted to Assistant Foreman. I would like to get him hired so that we can go ahead and start training him on all vehicles so there is a smooth transition once Richard retires, and Allen is full time in the Assistant Foreman position.

Sharmon Norwood – move from part time to full time status – request salary of \$31,200 Sharmon has been working past due accounts since the last week of December. We have \$319,684.42 in residential owed to us, and \$20,762.43 in commercial accounts owed. All these accounts (minus commercial) are around 90 days past due. In just a little over three weeks (she was off one week due to hours worked), she has collected \$4,537.82 while working on a part time basis. I would like to add, that she has only gotten through letter "C", and she also answers incoming calls and performs other administrative duties. I personally think this is quite impressive given the amount of time spent on these accounts. I feel this is something that needs to be addressed due to the amount of money owed to Lafayette County for services rendered. If we can catch these folks early enough, we have a better chance of getting paid when the amount is lower.

While I understand the annexation hit the county hard, we are still growing and will rebound from that loss in the next couple of years with the multiple subdivisions currently under construction. With her working these past due accounts, it could soften the initial blow and help bridge that gap of lost revenue.
