


**ORDER: ACCEPT REQUEST FROM ARENA ADVISORY COMMITTEE AND

Proposal to Allow Arts Council to Pursue Grants to Support Programming

The Horse Arena and Amphitheatre Committee recommends that the Board of Supervisors authorize the Yoknapatawpha Arts Council to act on behalf of the committee and board to pursue grants to support programs at the facilities.

Funds from the grants would be received by Lafayette County to support the program, facility and operational costs related to arena and surrounding area.

The Arts Council will submit a list of proposed grants opportunities to the County Administrator for the Arena & Amphitheatre Committee for approval prior to submission.

The Board would reserve the right to refuse awards or funds deemed not compatible with the proposed programming and uses of the facility. Funds would be disbursed through Lafayette County for approved expenses as defined in the grants.

The Arts Council will be responsible for all grant paperwork and final reporting requirements.

Any funds secured for capital improvements or equipment to be used at the facility would become property of the County
