During our review of Payroll procedures for Lafayette County, we noted the following discrepancies:

• The PERS Contribution for the Elected Official Retiree (Justice Court Judge) was not paid on the full amount of the regular compensation for the elective office held, but rather on the actual compensation paid to the Elected Official Retiree, as required by Section 25-11-127 (6)(b) Miss. Code Ann. (1972). This resulted in an underpayment of Employer PERS contributions in the amount of \$5,103.21.

Whenever issues are noted, we are required to discuss them with the agency before any further work is completed for the testwork performed.
