


**ORDER: ACCEPT JAIL MEAL LOG AND AFFIDAVIT FROM JAIL

Motion was made by Chad McLarty, duly seconded by Kevin Frye, to accept jail meal log and affidavit from jail administrator per section 19-25-74.


The vote on the motion was as follows:

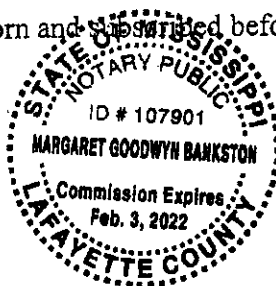
