

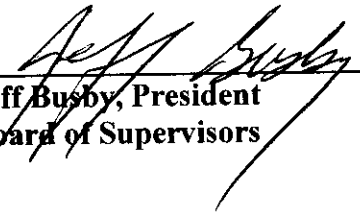
**ORDER: OPEN PUBLIC HEARING ON SPLINTER CREEK PHASE III

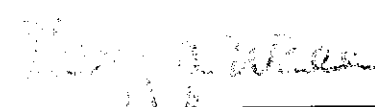

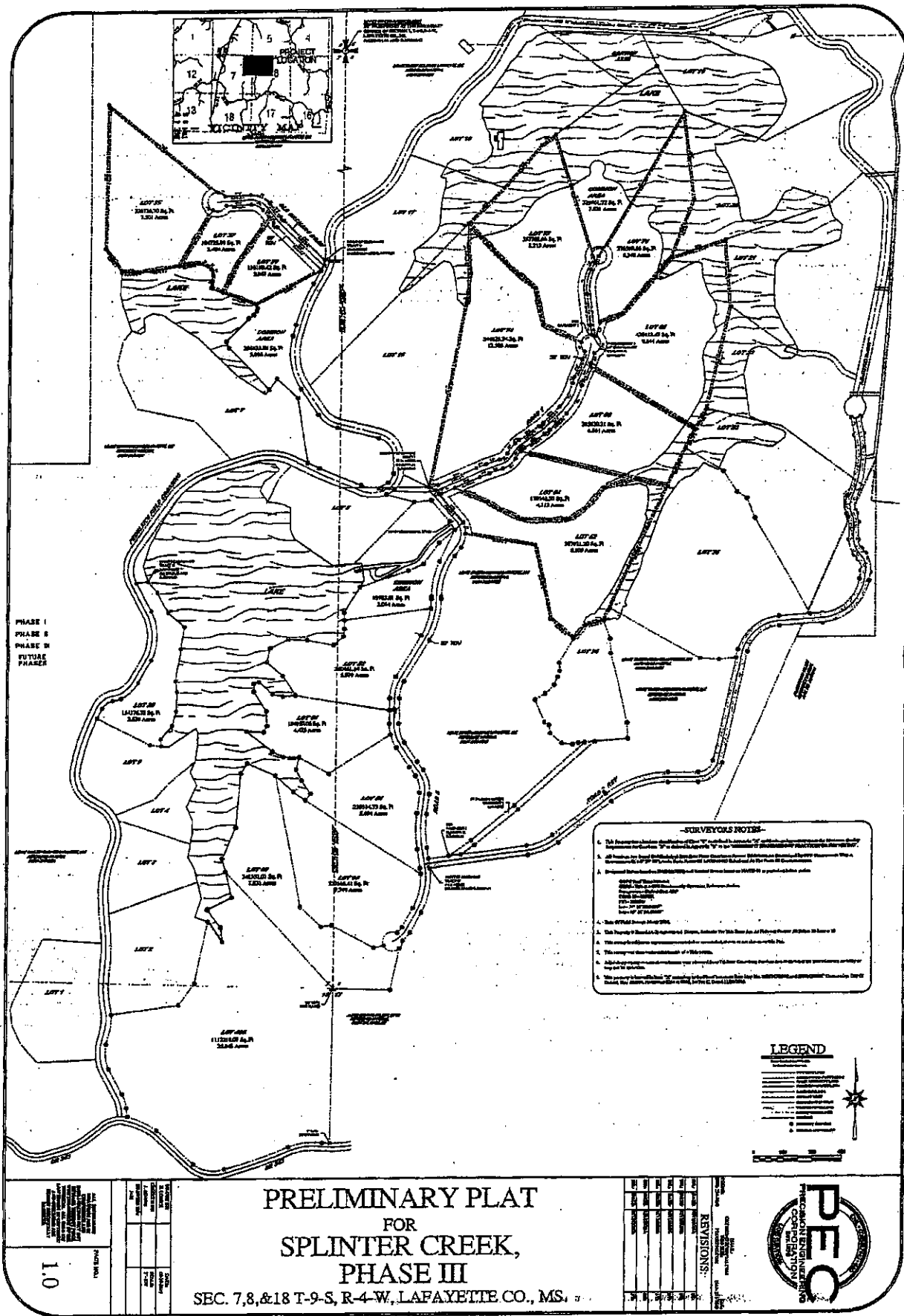

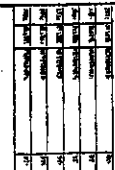
