

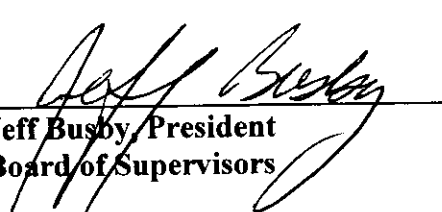
ORDER: AUTHORIZE SOLID WASTE WRITE OFFS FOR MAY. 2019
