MEMORANDUM OF UNDERSTANDING

BETWEEN

THE LAFAYETTE COUNTY SCHOOL DISTRICT

AND

LAFAYETTE COUNTY, MISSISSIPPI

- 1. PURPOSE. The purpose of this Memorandum of Understanding (MOU) between the Lafayette County School District and Lafayette County is to provide an Emergency Evacuation and Reunification site in the event of a natural or man-made disaster. This MOU is in support of Lafayette County School District Emergency Plan (the "Emergency Plan"). Specifically, these support areas are addressed as follows:
 - a. Providing a Evacuation and Reunification Site at the Lafayette County Arena / Multipurpose Building (the "Site") to evacuate the students of Lafayette School District in the event of an Emergency or Disaster as declared by the Lafayette County School Superintendent in accordance with the Emergency Plan and provide a location for reunification of students with their families or guardians. The time frame for use of the facility will be vary depending on the disaster or emergency as well as its overall impact to the community.
 - (1) Parking.
 - (a) Parking will be available to capacity for buses, teacher vehicles, student vehicles and parent vehicles.
 - (2) Security and Access.
 - (a) Any security needed would be the responsibility of the Lafayette County School District given the possibility the Resource Officers and Deputies may be unavailable due to the event.
 - (b) Access will be provided to the school district by contacting one of the 4 Arena Contact numbers.
 - (3) Utilization of facilities.
 - (a) Utilization of the Arena area for students with use of fans or heat as weather dictates.
 - (b) Use of the Extension Office Meeting Rooms as necessary for Reunification and Counseling Needs.
 - (c) Access to Restroom facilities on site.

(d) Access to Arena or Extension Office Internet to access the School Districts Web based system.

(4) Cost.

(a) The county will make available the parking, Arena, Extension Meeting rooms, and restrooms at no cost to the school district for emergency evacuation and reunification events.

(5) Points of Contact.

In the event the Lafayette County School Superintendent institutes the Emergency Plan and determines that an Evacuation and Reunification Site is needed, the Superintendent shall give notification of the institution of the Emergency Plan to the Lafayette County Administrator and make arrangements for access to the Site by contacting one or more of the following Lafayette County designated contacts:

The designated contacts are hereby authorized by the Lafayette County Board of Supervisors to grant access to the Site pursuant to this Memorandum of Understanding.

- 3. EFFECTIVE DATE. This Memorandum of Agreement is effective upon the date of approval of the respective governing Boards and the execution of this Agreement by the Superintendent of Lafayette County School District and the President of Board of Supervisors of Lafayette County.
- 4. TERMINATION: This agreement is effective until action by the Lafayette County Board of Supervisors terminates it or by written request by the Lafayette County School District Superintendent of Education.
