

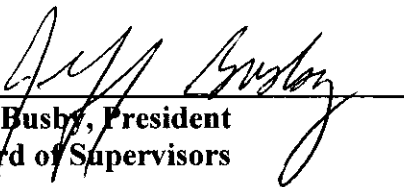

Motion was made by Chad McLarty, duly seconded by David Rikard, to approve mobile home, personal property insolvency list and return check list.

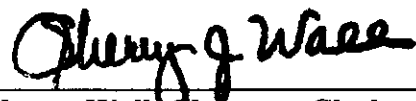
