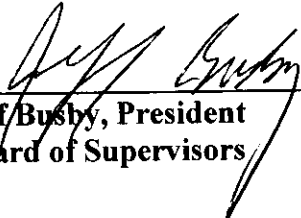
**ORDER: APPROVE PLANNING COMMISSION RECOMMENDATION FOR FINAL

Motion was made by Kevin Frye, duly seconded by Chad McLarty, to approve planning commission recommendation for final site plan approval of Old Oaks Phase VI.

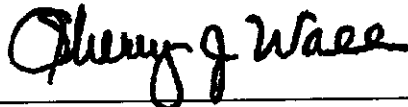
The vote on the motion was as follows:

Supervisor Mike Roberts, voted yes

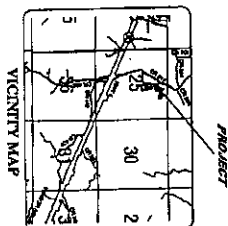
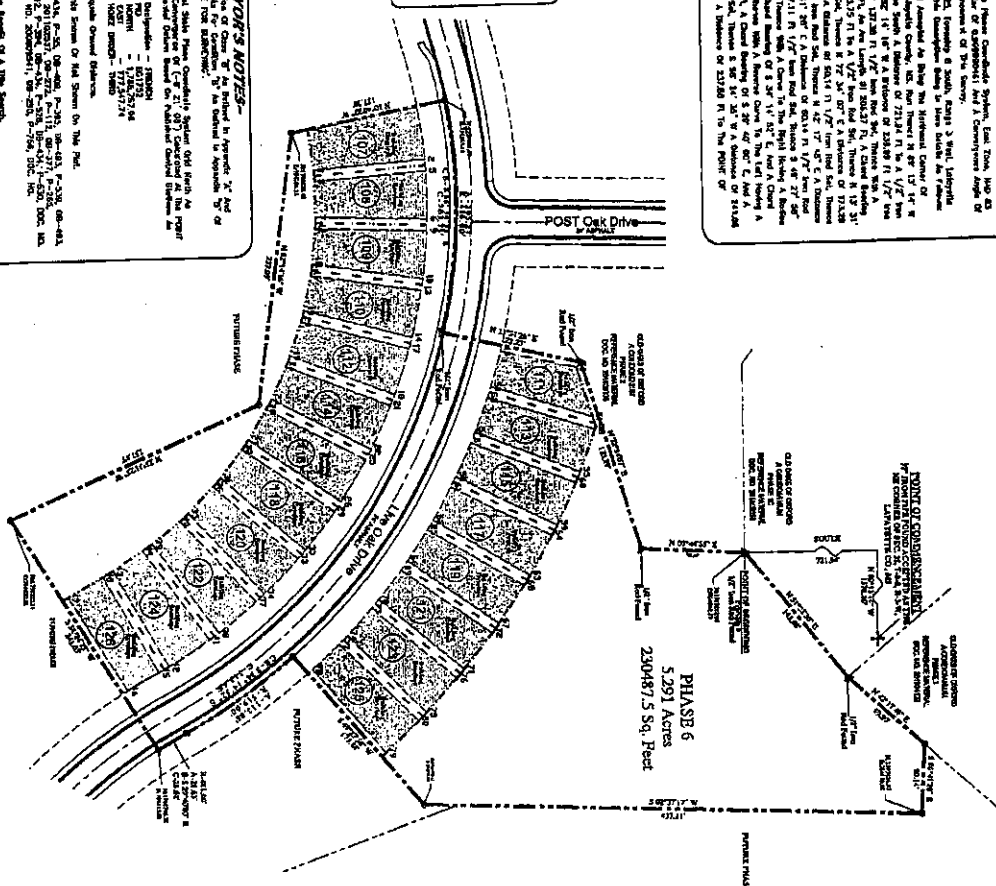
After the vote, President Busby, declared the motion carried, this the 7th day of October, 2019.
