Motion was made by Chad McLarty, duly seconded by Brent Larson, to authorize deletion of fixed assets.


The vote on the motion was as follows:

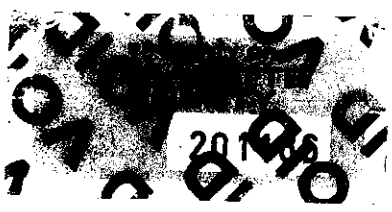
