

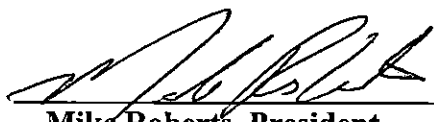
ORDER: APPROVE WRITE OFFS OF SOLID WASTE ACCOUNTS

Motion was made by Chad McLarty, duly seconded by Larry Gillespie, to approve write offs of Solid Waste accounts from June, 2020.

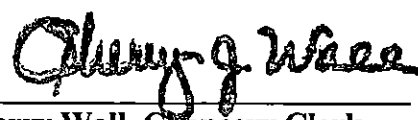
The vote on the motion was as follows:
