

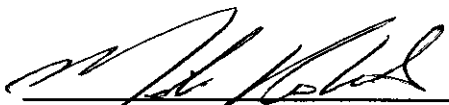
ORDER: APPROVE SOLID WASTE WRITE OFFS FOR SEPTEMBER, 2020

Motion was made by Larry Gillespie, duly seconded by Brent Larson, to approve Solid Waste write offs for September, 2020.

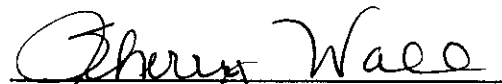
The vote on the motion was as follows:
