Motion was made by Brent Larson, duly seconded by Larry Gillespie, to approve Account Adjustment Register for Solid Waste Department.

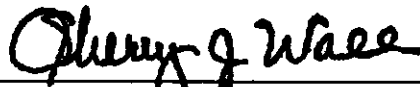
The vote on the motion was as follows:
