

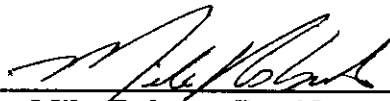
**ORDER: APPROVE WRITE OFF OF SOLID WASTE ACCOUNTS FROM

Motion was made by Larry Gillespie, duly seconded by Chad McLarty, to approve write off of Solid Waste Accounts from June 2021.

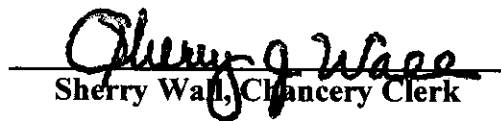
The vote on the motion was as follows:
